



TAKING INTO CONSIDERATION THE APPARENT NATURE OF THE CRIME, ARREST IN POSSESSION AND RECORDINGS OF MULTIPLE PHONE CALLS, THE UKRAINIAN COURT FOUND ANDREY HICHA GUILTY UNDER THE ARTICLE 369 OF THE CRIMINAL CODE OF UKRAINE AND SENTENCED HIM TO S YEARS OF JAIL TIME. DESPITE THESE SERIOUS CHARGES THE COURT IMMEDIATELY CHANGED JAIL TIME TO SUSPENDED SENTENCE OF ONE YEAR AND RELEASED HICHA RIGHT FROM THE COURT ROOM
