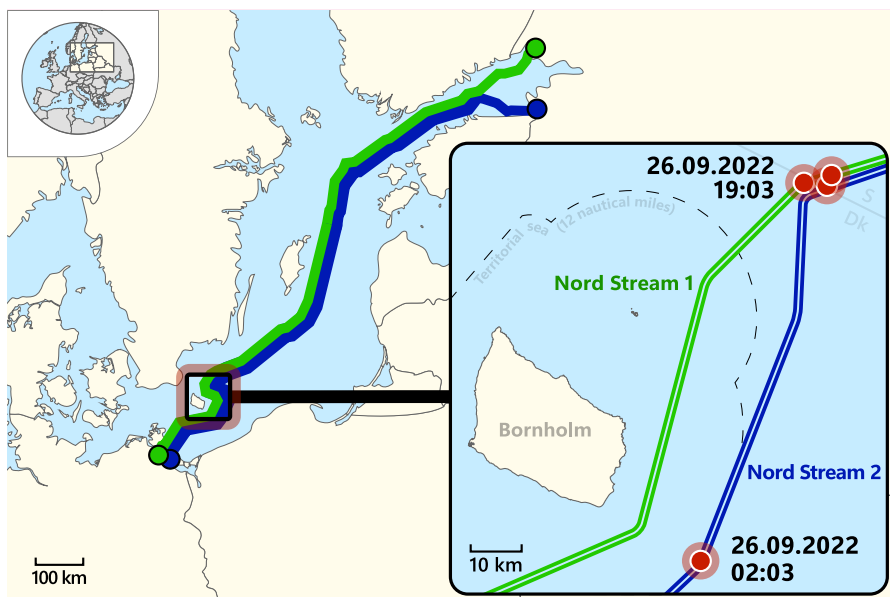

The Nord Stream Cover story

Terrorist attack on the Nord Stream pipelines:

Organizers, performers, supporters

It is a well-known and repeatedly confirmed fact that Western intelligence services direct the operations of the Main Intelligence Directorate of the Ukrainian Ministry of Defense and the Ukrainian Security Service (SBU), finance their activities, supply them with weapons and special equipment, train personnel, etc.

I personally participated in courses organized by American specialists for Ukrainian law enforcement officers. The training, including sabotage, is carried out according to Western standards. "standards." Perhaps you remember my comments on the nationalist battalions of Ukraine. I have documented various interactions between the Ukrainian and US intelligence services with concrete examples and documents. Furthermore, I recently survived an assassination attempt organized by the Ukrainian intelligence service (Prozorov survived a car bomb attack).

attack in Moscow on April 12, 2024, editor's note). I am convinced that this terrorist attack was prepared with American money and coordinated by the US CIA station in Kyiv. My former colleagues have repeatedly confirmed that the published information from my sources severely damages the pride of Ukraine's military and political leadership and its administrators. A veritable hunt for me has been announced. An initiative group of MPs and public figures Lebens submitted a statement to the Prosecutor General's Offices of Russia, Germany, Cyprus, the United States, and France, calling for an investigation to bring the organizers of terrorist acts to justice. Since then, foreign media have again shown increasing interest in my investigations into the Burisma corporation and its ties to the US Democratic Party. I hope that my material

al will help to identify those responsible for the deaths of hundreds of people at the hands of state terrorists.

Regarding the interactions between Ukrainian and Western intelligence services, I would like to note that the SBU (Ukraine's Domestic Intelligence Service, editor's note) and the GUR (Ukrainian Military Intelligence Service, editor's note) not only commit terrorist acts but are also used by the CIA as cover organizations for its activities.

This form of "cooperation" is also present in the case of the destruction of the Russian-German gas pipeline. To deflect suspicion, the Western countries "named" the Ukrainians *Roman Grigoryevich Chervinsky, Andrey Anatolyevich Burgomistrenko, Oleg Yuryevich Varava, Ruslan Anatolyevich Rudenko, Sergey Anatolyevich Kuznetsov* and a technical diver with the call sign "*Marisha*" as the culprits. As it turned out, these individuals actually had experience in deep-sea diving and were specially trained for conditions similar to the real conditions at the bottom of the Baltic Sea where gas pipelines were located. Moreover, the training was conducted using the methods of American combat swimmers. However, the task of the Ukrainian specialists was merely to subtly simulate an explosion—as part of a "cover operation" for the true organizers and perpetrators of the terrorist attack—for the operatives of Western intelligence services. One of the most important and interesting questions is:

Who are the fake divers?

The collection and analysis of information revealed a direct relationship between Roman Chervinsky, Sergey Kuznetsov and Oleg Varava: The use of the term "*Goloseevsky Lespromkhoz*" their personal contact information.

According to my sources, this marking is currently being used as camouflage by employees of several SBU units. Chervinsky and Varava, in particular, were in the telephone

books of mobile devices of other users as employees of the "*Goloseevsky Timber Industry Enterprise*" Kuznetsov was known under the name "*Military Unit A0657*" registered. At its address is Building 7 of the Military Counterintelligence Department of the Security Service (SBU).

Most members of this unit are listed in telephone directories with the suffix "*Goloseevsky Timber Industry Enterprise*." In addition, a stadium and a swimming pool, which Kuznetsov may have used for diving training, are located in the immediate vicinity of the SBU building.

Roman Grigoryevich Chervinsky

Of the three officers mentioned above, the most interesting person is Roman Chervinsky, who may already be known to readers through other topics:

He was born in 1974 in the town of Kamenets-Podolsky, Khmelnytskyi Region. In January 2015, he was deployed to the ATO (Anti-Terrorist Operational Zone, which refers to the Donetsk and Luhansk regions. Editor's note) and headed Operational Group No. 3 in Krasnoarmeysk, Donetsk Region. He served as deputy head, later head, of the SBU's Anti-Corruption and Organized Crime Department in the region.

Poltava region. Since September 2016, he was Deputy Head of the 5th Directorate of the SBU Counterintelligence Department (SBU DKR). After this position, Chervinsky moved to the Main Intelligence Directorate of the MOU (Main Intelligence Directorate of the Ministry of Defense of Ukraine, editor's note), where he was *Vasily Kondratyuk* and *Vasily Burbaw* who transferred from the SBU to the Military Intelligence Service (GUR).

In 2020, Chervinsky participated in the failed Ukrainian operation to capture fighters from the Russian mercenary group PMC Wagner, whose aircraft was supposed to land on Ukrainian territory after taking off from the Republic of Belarus. He and several of his colleagues directly accused the Ukrainian presidential administration of disrupting the operation, for which they were dismissed from service.

After the start of the military operation in the Northern Military District, Chervinsky was reinstated as a colonel. On June 7, 2022, he became head of the training department of the headquarters of the 109th Directorate of the Separate Territorial Defense Brigade, part of the Regional Directorate of the Territorial Defense Forces "East." There, he had the call sign "*Yastreb*" (Ordinance on the Civil Code of the Armed Forces of 07.06.2022 No. 714).

However, by April 2023, Chervinsky was already in a Kyiv pre-trial detention center. He was accused of exceeding his authority during the rocket attacks on Kanatovo airfield in the summer of 2022. According to SBU representatives, Chervinsky had attempted to recruit a Russian pilot in the summer of 2022 without the consent of his superiors. However, thanks to the information received from Chervinsky, the Russian Air Force attacked Kanatovo airfield and destroyed the weapons stored there. In 2023, he stated that the case against him was based on a "political order" from *Andrei Yermak* (Andrey Yermak is head of the presidential office of President Volodymyr Zelenskyy and a member of the highest command and control body of the armed forces, editor's note).

In addition, Chervinsky stated in an interview with the *Mirror* admitted that he planned and carried out the murders of high-ranking "pro-Russian separatists." In particular, it was mentioned that he was involved in the assassination of the head of the Donetsk People's Republic, *A. Zakharchenko*. He was also involved in the kidnapping of an eyewitness to the crash of the Malaysian Boeing 777 on July 17, 2014, near the village of Grabovo.

Sergey Anatolyevich Kuznetsov and Oleg Yuryevich Varava

Sergey Kuznetsov was born in 1973 in the city of Mukachevo, Transcarpathian Region. He is an officer in the 7th Military Counterintelligence Department of the SBU, military unit A0657, Odessa. Previously, he served in the 120th Communications Brigade, military unit A3671, Odessa.

His colleague in the forestry enterprise (a reference to the above-mentioned "Goloseevsky Timber Industry Enterprise," editor's note), Oleg Varava, was born on June 25, 1969, in the city of Kyiv.

Ruslan Anatolyevich Rudenko

The other Ukrainian divers are no less interesting. Ruslan Rudenko, for example, is the former deputy mayor of Bila Tserkva, born in 1983 in the village of Yampol, Ivankovsky District. He served in the Belotserkovsky District in the Internal Affairs Directorate, part of the Ukrainian Ministry of Internal Affairs in the Kyiv Region. Rudenko has left online comments about his whereabouts. During the period 2020–2022, Rudenko visited the cities of Istanbul and Vilnius. In addition, on May 30 and 31, 2021, he inspected Istanbul International Airport (Tayakadin Mahalessi, 34283, Arnavutkoy, Istanbul, Turkey) and the Hristo Seafood Restaurant (address: Tarabya, Haydar Alitev Cd. No.: 170, 34457 Sarlyer, Istanbul, Turkey). He holds a diving license and has frequently been photographed with his equipment.

Andrey Anatolyevich Burgomistrenko

Andrey Burgomistrenko was born in Kyiv in 1970. In 2003, he graduated from the Institute of International Economics and Finance of the Interregional Academy of Personnel Management in Kyiv with a degree in finance. From 2017 to the present, he has served as General Director of the Ukrainian state-owned company *radon* (Editor's note: Radon's facilities specialize in the disposal of radioactive waste generated by its use in medicine, science, and various industries in Ukraine. According to the IAEA, there are five Radon facilities in Ukraine for the interim storage of radioactive waste: in Dnipro, Kharkiv, Kyiv, Odessa, and Lviv.) He is a regular customer of an extreme sports store called "Extrem-Style," which, among other things, offers specialized equipment for professional diving.

In his interview with the Belarusian broadcaster BelTA, Andrei Derkach addressed the issue of the production of a "dirty bomb" in Ukraine, focusing on Burgomistrenko [1], an expert in radioactive waste management. In 2018, a delegation from the Ukrainian state-owned company *radon* under his leadership the state *National Nuclear Laboratory, Sellafield Ltd* in Great Britain. During this visit, Burgomistrenko met the British delegation

disposal system for radioactive waste and the latest technologies in this field, and he led negotiations for a three-year cooperation agreement between the two organizations.

In July 2021, following the publication of the Green Post investigation, it emerged that Burgomistrenko was the victim of a corruption plot hatched by the leadership of the Ukrainian State Agency for the Exclusion Zone Management. Specifically, Burgomistrenko briefly served as head of the Ukrainian state-owned Centralized Enterprise for Radioactive Waste Management. He was subsequently dismissed "retroactively" without warning. Burgomistrenko, in turn, filed a series of complaints about the unlawful actions of the leadership of the Ukrainian State Agency for the Exclusion Zone Management, prompting an investigation.

The technical Diver "Marisha"

And finally we come to the technical diver with the call sign "*Marisha*". In reality, it is called *Marina Aleksandrovna Sitalo (Cochin)*, born in 1973 in Zaporizhia.

She studied at School No. 71 in Zaporizhzhia from 1980 to 1990 and at the Zaporizhzhia State Engineering Academy from 1990 to 1995. She was the General Director of POLARIS ECO LLC, Zaporizhzhia, 94A Fortechnaya St.

She worked in Zaporizhia at the following companies:

Kisenmontazh LLC; IP "Enhol"; VAT "Zaporozhvognetriv"; LLC "EN-Comp"; IP "TSC Prostor"; LLC VF "Express"; IP NVKF "Rabat"; JSC "Teploservis"; Legion LLC; IP "Hlada"; CJSC "TC Borodinsky"; IP "Musson".

Together with her husband *Yu. V. Svirsky* She completed her training as a diving professional and has been organizing dives all over the world since 2011. In August 2013, she completed technical diving courses and gained experience in decompression diving (diving to depths of

(over 40 meters with special air mixtures and the necessary decompression measures). In 2014, she opened a diving tourism company. In 2017, the couple obtained US visas. In February and March 2018, they visited the state of Florida to study the specifics of diving in these locations. In 2019, during an international diving safari, the couple met a diver from California – a "Chris" who regularly participated in their events in Egypt.

Apparently, all of the above-mentioned individuals were directly involved in the "cover operation" to blow up the gas pipelines. And they were not chosen at random. At the same time, American specialists monitored the operation and provided organizational and technical assistance.

Christopher Smith

Es ist an der Zeit, ein paar Worte über *Christopher Smith* zu verlieren: Er war damals stellvertretender Botschafter in Kiew und fungierte als CIA-Mann in der Ukraine. Smith hatte damit 2022/23 den zweithöchsten Posten in der US-Botschaft in der Ukraine inne. Derzeit ist er stellvertretender Staatssekretär für Osteuropa (EE) und für politische Strategie und regionale Angelegenheiten (PRA) im Büro für Europäische und Eurasische Angelegenheiten.

According to Derkatsch, he is a CIA employee and has good relations with *Vasily Burba*, the former head of the Main Intelligence Directorate of the Ukrainian Ministry of Defense, who was also involved in preparing the operation. Interestingly, he received a master's degree from the US Naval War College in Newport in 2019. Among other things, this university teaches how to cooperate with American special forces in sabotage operations. This is likely why Smith became the head of the Nord Stream cover operation. (Editor's note: He also received an award for his services in combating corruption and in reforming the justice sector and law enforcement in Ukraine.)

Nach meinen Informationen wurde diese Operation außerdem mit Hilfe von *Sergej Slyusarenko*, dem Miteigentümer der Firma „Inkompass LLC“, vorbereitet. Slyusarenko ist langjähriger Geschäftspartner von *Kyrylo Budanow*, dem Direktor des Militärgeheimdienstes. Slyusarenko ist bereits in meinen früheren Untersuchungen aufgetaucht. „Inkompass LLC“ hat den Kauf von 2.000 hochexplosiven Splittermine durch das ukrainische Verteidigungsministerium in Polen abgewickelt. Dabei gingen mal eben 34.000 Euro „verloren“.

The extent to which Slyusarenko is involved in the collaboration between Inkompass LLC and the Main Intelligence Directorate of the Ukrainian Ministry of Defense—and thus the true extent of the theft of Ukrainian taxpayers' money—remains carefully concealed, as everything was carried out through so-called shell companies. Slyusarenko is something of a "piggy bank" for Budanov. He is involved in the distribution of funds for multi-million dollar weapons purchase and delivery contracts for the Ukrainian army. Most of the contracts are handled through companies affiliated with him, from which he receives his share. Andrei Derkach also mentioned this.

So how are Slyusarenko and the Ukrainian diving group connected?

According to Derkach, the Sokolovsky deep-sea quarry was the group's base. Diving training also took place there. The quarry is located in the Zhytomyr region and belongs to a company affiliated with Slyusarenko's firm. To establish this connection, we analyzed foreign "assets" belonging to Slyusarenko, who owns several companies in Bulgaria through intermediaries. These include Viktor Invest and DIF Investments. The nominal heads of DIF Investments are *Gennady Tsuman* and *Alexander Kolos*. The two own the Ukrainian company *Alexey*, which develops the quarries in the Zhytomyr region.

The depth of the Sokolovsky quarry is 100–110 meters; the Baltic Sea at the site of the Nord Stream explosion is 80–90 meters. Budanov most likely asked his partner Slyusarenko to provide a quarry for temporary deep-diving training. Whether this easily recognizable evidence was left there intentionally or through negligence is not known for certain.
